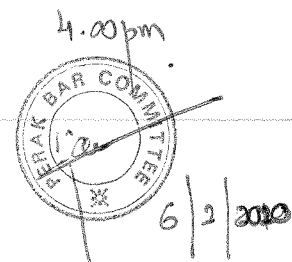

**MOTION TO REVIVE THE PRACTICE OF THE APPEAL COURT
AS A CIRCUIT COURT**


1. WHEREAS the Courts of Appeal and its predecessors (the erstwhile Federal Court and Supreme Court and before that the respective Courts of Appeal in the Federated Malay States) was a circuit court which travelled around the country to hear appeals;
2. AND WHEREAS this practice has worked to the advantage of lawyers and their clients by reason of convenience and relieving them of the stress of long travel and problems with finding reasonably priced accommodation;
3. AND WHEREAS litigants in Perak are able to engage local lawyers whose standards of advocacy have been said to be second to none compared to those in Kuala Lumpur;
4. AND WHEREAS the Perak Bar recalls the meaningful and proud tradition of State Bars hosting the Appellate Judges and getting to socialize meaningfully when they arrived on circuit to hear appeals; and
5. AND WHEREAS it is a fundamental constitutional right of all Malaysians to have equal and convenient access to the courts both at first instance and at the appellate stages.

IT IS HEREBY RESOLVED:-

that the Perak Bar do take immediate steps to revive the practice and tradition of the Court of Appeal and the Federal Court to go on circuit and hear appeals outside the Federal Capital
