MOTION TO IMPOSE TERM LIMITS ON ALL OFFICE BEARERS OF THE PERAK BAR COMMITTEE

WE HOLD:-

1. THAT in the spirit of transparency and good governance it is prudent for the Perak Bar Committee office bearers to hold office for a fixed number of terms;
2. AND THAT this fixed term in office shall lead to greater accountability as well as to provide more room for growth of new leadership within the Perak Bar Committee;
3. AND THAT this shall encourage junior practitioners to be greatly involved in the activities of the Perak Bar Committee and shall lay a strong foundation of leadership in future office bearers of the Perak Bar Committee;
4. AND THAT this shall serve to train and equip junior practitioners to undertake the responsibilities of the Perak Bar Committee thus ensuring continuity of leadership in the Perak Bar Committee;

THEREFORE, IT IS HEREBY RESOLVED THAT:-

(1) The Perak Bar Committee shall consist of elected and appointed office bearers whereby:
