

MINUTES OF THE 35TH ANNUAL GENERAL MEETING OF THE PERAK BAR HELD ON FRIDAY, 19th FEBRUARY 2021 VIA ZOOM

- 1. The meeting was called to order at 2.30p.m. by the Chairman, Mr. Babu Raj Raja Gopal. The Chairman welcomed and expressed his gratitude to the members for attending the 35th Annual General Meeting (AGM) of Perak Bar.
- 2. The Chairman invited the members to be upstanding to hold a moment of silence for members who are no longer around.
- 3. The Chairman then invited the members to refer to page 3 of the Perak Bar Annual Report 2020/2021 for the agenda of the 35^{th} AGM.

<u>Item 1 – To Confirm and Adopt the Minutes of The Perak Bar Annual General Meeting Held</u> <u>On 14th February 2020</u>

- 4. Mr. Chairman made an amendment to the Annual Report at page 6, **paragraph 32** which should read as follows: -
 - "Mr. Balakrishnan Balaravi Pillai proposed the nominations for the Chairman to be closed and this was seconded by *Mr. Santhiran*."
- 5. Mr. Purshotamdas A/L Nathermal made an amendment to the Annual Report at Page 2, amending a spelling error to the word "*Conveyancing*".
- 6. Mr. Purshotamdas A/L Nathermal proposed that the minutes be passed, and this was seconded by Mr. Gary Abraham A/L Xavier.

<u>Item 2 – To Consider Matters Arising from The Above Previous Minutes of the AGM</u>

7. There were no matters arising from the previous minutes of the AGM.

<u>Item 3 – To Consider and Adopt the Annual Report 2020/2021</u>

- 8. The Annual Report at page 12 to 58 were perused by the members.
- 9. Mr. Choy Kam Lee proposed that the Annual Report be adopted, and this was seconded by Ms. Ma Foong Yin.

Item No. 4- To Consider and Pass the Accounts for The Period of 1.1.2020 to 31.12.2020

- 10. The Balance Sheet, Income, Expenditure Accounts, Cash Flow Statements and Report of the Internal Auditors were perused from page 17 to 21.
- 11. En. Taqrir Akramin Bin Khalib proposed that the accounts be passed, and this was seconded by Mr. Santhiran A/L Veloo.

Motions

- 12. The Chairman informed the floor that there is a motion before the committee.
- 13. The motion was by Mr. Amrick Singh Sandu titled Imposing Term Limit on all Office Bearers of the Perak Bar Committee.
- 14. The Chairman then invited Mr. Amrick Singh Sandu to present and speak about the motion.
- 15. Mr. Amrick Singh Sandu addressed the floor on the issue with the term 'office bearers' and clarified that the term 'office bearers' in the said motion includes all the Committee Members of the Perak Bar.
- 16. Mr. Santhiran A/L Veloo stated that the Young Lawyers' involvement in the Committee is a process and there is no need for a rule such as this to be imposed. Furthermore, there is a convention that a Chairman of the Perak Bar will only serve for two terms.
- 17. Mr. Choy Kam Lee stated that the intention of this motion is good, but this would require an amendment to the Legal Profession Act 1976 (LPA) to a certain extent and questioned whether there has there been any complaint of abuse of power, cronyism, or corruption within the Perak Bar Committee to date.
- 18. Dato' Naranya Singh S/O Asa Singh stated that the motion may be in contravention of the LPA but is intended for the Perak Bar members to take cognizance and give way to new people into the Perak Bar Committee.
- 19. Ms. Lee Pooi Mun informed that as a point of order, the speaker should only state whether they support or oppose the motions and give their reasons. There is no need for a reply by the proposer of the motion, to the speakers' reasons.
- 20. Mr. Surindar Singh S/O Chain Singh informed that he does not support the motion as it is contrary to the LPA. His reasons are that the term 'more than two terms continuously' is not present in the LPA and that the AGM of the State Bar is governed under the Section 70(5) of the LPA which provides that the Chairman and the members of the Committee so elected shall hold office until the next AGM of the State Bar. He further stated that the Chairman and the Committee Members are elected every year. Instead, the motion should be to amend the LPA.
- 21. Mr. Purshotamdas A/L Nathermal pointed out the existence of the Perak Bar Convention wherein the Chairman of the Perak Bar will always carry on as the Chairman for two terms. The Committee can look into the convention. He then referred to page 7 of the Annual Report where ten (10) Committee Members were nominated at paragraph 44 and proposed that the person proposing nominations be

- closed should not be part of the nominated members, which may be formed as part of the Perak Bar Convention.
- 22. The motion was called for voting and the first motion by Mr. Amrick Singh Sandu was defeated with 30 votes for the motion and 67 votes against the motion.
- 23. The Chairman thanked Mr. Amrick Singh Sandu for tabling the motion.

<u>Item No. 5- To Elect the Chairman of the Perak Bar Committee for the Year 2021/2022.</u>

- 24. Before the nominations and election began, the Chairman declared that the chair of the Perak Bar was vacant and called for the nomination from the floor. The Chairman also thanked all the previous Committee for the hard work. The Chairman then invited Mr. Mathialagan s/o Mathuramuthu to chair the meeting accordingly as Elections Officer.
- 25. Mr. Mathialagan s/o Mathuramuthu announced that the nominations for the Chairman was open.
- 26. Mr. T. Ellanggovan A/L Thambiraju proposed Mr. Babu Raj A/L Raja Gopal as the Chairman for the year 2021/2022 and this was seconded by Ms. Kiranjeet Kaur Sidhu A/P Charan Singh.
- 27. Mr. Thomas Su proposed the nominations for the Chairman be closed and this was seconded by Ms. Lee Pooi Mun.
- 28. Mr. Mathialagan s/o Mathuramuthu announced Mr. Babu Raj A/L Raja Gopal as the Chairman of the Perak Bar Committee for the year 2021/2022.

<u>Item No. 6 - To Elect Ten Members of the Perak Bar Committee for 2021/2022</u>

- 29. Mr. Santhiran A/L Veloo proposed Mr. Amrick Singh Sandu, and this was seconded by Mr. Surindar Singh A/L Chain Singh.
- 30. Mr. Thomas Su proposed Mr. Kenny Lai Choe Ken, and this was seconded by Ms. Fong Po Kuan.
- 31. Mr. Amrick Singh Sandu proposed Ms. Mary Ann, and this was seconded by Ms. Kiranjeet Kaur Sidhu A/P Charan Singh.
- 32. Mr. Purshotamdas A/L Nathermal proposed Ms. Kamala Mahlini A/P P Jeganathan, and this was seconded by Mr. Thomas Su.
- 33. Ms. Lee Pooi Mun proposed Dato' Shamsuriah Binti Sulaiman, and this was seconded by Pn. Nurul Jannah Binti Khairul Anuar.

- 34. Mr. Shassidaren A/L Deva Sana Pathy proposed Mr. Sukhvinder Singh Sidhu, and this was seconded by Mr. Privesh Paul Singh.
- 35. Mr. T. Ellanggovan A/L Thambiraju proposed Mr. Vivekanandan AMS Periasamy, and this was seconded by Mr. Thomas Su.
- 36. Ms. Tan Yin Fong proposed Pn. Ruzitah Binti Sarbani, and this was seconded by Mr. Varpal Singh A/L Menender Singh.
- 37. Mr. Harveynder Singh Tyndall proposed Mr. Balakrishna Balaravi Pillai, and this was seconded by Mr. Privesh Paul Singh.
- 38. Mr. Vivekanandan AMS Periasamy proposed Pn. Nurul Jannah Binti Khairul Anuar, and this was seconded by Mr. Varpal Singh A/L Menender Singh.
- 39. Pn. Ruzitah Binti Sarbani proposed Ms. Tan Yin Fong, and this was seconded by Mr. Kenny Lai Choe Ken.
- 40. Pn. Nurul Jannah Binti Khairul Anuar proposed Mr. Varpal Singh A/L Menender Singh, and this was seconded by Mr. Sukhvinder Singh Sidhu.
- 41. Dato' Naranya Singh S/O Asa Singh proposed Dato' Shamsuriah Binti Sulaiman to withdraw the nomination and Mr. Mathialagan s/o Mathuramuthu stated that he cannot do so and invited Dato' Naranya Singh to propose another candidate.
- 42. Mr. Robert S Gnanarajan proposed Mr. S.V. Namasoo, and this was seconded by Mr. Thomas Su. Mr. S.V. Namasoo had declined the nomination.
- 43. Dato' Naranya Singh S/O Asa Singh proposed Ms. Kiranjeet Kaur Sidhu A/P Charan Singh, and this was seconded by Mr. Balakrishnan Balaravi Pillai. Ms. Kiranjeet Kaur Sidhu A/P Charan Singh has withdrawn the nomination.
- 44. Dato' Naranya Singh S/O Asa Singh proposes that nominations be closed, and this was seconded by Ms. Lee Pooi Mun.
- 45. Members were then members are invited to vote for ten (10) candidates of the twelve (12) nominations.
- 46. Mr. Mathialagan s/o Mathuramuthu announced the ten (10) candidates who were elected as Members of the Perak Bar Committee for the year 2021/2022, namely:

<u>Items No. 7- To Elect One (1) Member to Represent the Perak Bar to the Bar Council for the Year 2021/2022</u>

- 47. Mr. Santhiran A/L Veloo proposed Mr. S.V. Namasoo, and this was seconded by Mr. Surindar Singh A/L Chain Singh.
- 48. Ms. Kiranjeet Kaur Sidhu A/P Charan Singh proposed Dato' Naranya Singh S/O Asa Singh. Dato' Naranya Singh S/O Asa Singh has declined the nomination.
- 49. Mr. Lim Yun Edmund proposed Mr. Purshotamdas A/L Nathermal, and this was seconded by Ms. Kiranjeet Kaur Sidhu A/P Charan Singh. Mr. Purshotamdas A/L Nathermal has declined the nomination.
- 50. Mr. Thomas Su proposed the nominations to be closed and this was seconded by Dato' Naranya Singh S/O Asa Singh.
- 51. Mr. S.V. Namasoo was therefore elected as the Perak Bar Representative to the Bar Council for the year 2021/2022.

<u>Item No. 8 - To Appoint Two (2) Honorary Auditors</u>

- 52. Mr. Kenny Lai Choe Ken proposed Mr. Purshotamdas A/L Nathermal, and this was seconded by Mr. Vivekanandan AMS Periasamy.
- 53. Mr. Babu Raj Raja Gopal proposed Ms. Lee Pooi Mun, and this was seconded by Pn. Ruzitah Binti Sarbani.
- 54. Ms. Kamala Mahlini A/P P Jeganathan proposed for nominations to be closed, and this was seconded by Pn. Nurul Jannah Binti Khairul Anuar.
- 55. Hence, Mr. Purshotamdas A/L Nathermal and Ms. Lee Pooi Mun were thereby appointed as the two (2) Honorary Auditors for the term of 2021/2022.

<u>Item No. 9 - General Matters Arising</u>

56. Ms. Fong Po Kuan congratulated the Chairman on his re-election as the Perak Bar Chairman and thanked Ms. Kamala Mahlini A/P P Jeganathan for heading the Conveyancing Sub-Committee. She urged the sub-committee to follow up with the issues with e-Tanah. She informed that the e-Tanah system was launched with no quota on presentations, however, she was still unable to present her documents on

that day. A quota of five (5) presentations per person was imposed the following day. She hoped that there will be a two-way co-operation between the PTG and the Perak Bar.

- 57. Ms. Kamala Mahlini A/P P Jeganathan informed the last 'taklimat' on e-Tanah which was held in July 2020 was with the operator of the system and no representative from PTG was present. Hence, the issues were not addressed satisfactorily. A follow up letter was sent to the PTG Pengarah which should be addressed before the implementation of e-Tanah but there was no response. She was only informed that the e-Tanah system will not be fully implemented yet.
- 58. Ms. Lee Pooi Mun further informed that further to a meeting, the PTG had informed the date that the e-Tanah system will be implemented. The PTG also informed that there will a helpline open and tutorial video at the portal to assist members in the e-Tanah system. The limit on presentations is only enforced due to MCO and CMCO and the staff are unable to operate the e-Tanah from home.
- 59. Mr. Purshotamdas A/L Nathermal congratulated the Chairman and the new Committee for their election. He then stated that care should be taken with regards to the Seniority List at page 60 of the Annual Report and pointed out a senior member of the Bar who is no longer with us. Mr. Babu Raj Raja Gopal clarified that the list is generated by the Bar Council.
- 60. There being no other matters, the Chairman thanked the Members for attending the AGM. The AGM was adjourned at 4.40 p.m.

CHAIRMAN'S REPORT



Let me start by thanking you for giving me the opportunity to serve as your Chairman. I have completed my 2 terms as Chairman of Perak Bar Committee.

I append a few:-

i. Renovation to Perak Bar Building

- Our plans were to extend the current building another 30 feet and thereafter build a 3 storey building at the back which will comprise a board meeting room, extended conference hall with high tech media with seating capacity of 350 person and a library.
- We have written to Majlis Bandaraya Ipoh for clarification and relaxation of the 10 feet 'setback rule'. We are still waiting for reply from the local authority. For members information, we have sufficient fund to carry out the renovation.

ii. Online Payments

- Members are well aware that we have revamped our website [perakbar.org] with modern look. To ease members making payments, we have applied for online payment gateway and it has been approved. We are in the midst of integrating the same to our website.

iii. Perak Bar Apps

- We have proposed for phone apps so that we can disseminate information to our members easily. If the project is a success, we would be the first state Bar to have personalised apps.

I sincerely hope that incoming committee will carry out these initiatives and I am prepared to lend a hand.

BAR REPRESENTATIVE REPORT

The inaugural year of being the Bar Representative had its own challenges, from understanding the mechanics of how the Bar Council (BC) functioned to that of the duties and the responsibilities of being a Councillor tasked with looking after the affairs and welfare of its 21,502 members in Peninsular Malaysia as of 31.12.2021 and at the same time ensuring that the Bar upholds its functions as statutorily enshrined.

I believe, unlike any other year, BC in the year 2020/2021 had more than its fair share of challenges and issues to deal with due to the unexpected and sudden onset of the Covid 19 pandemic and the consequent imposition of the nationwide movement control order on 18.3.2020. For nearly 6 months all BC as well as Committee meetings were all conducted vide zoom. Similarly, all meetings with the judiciary, relevant government agencies and other stakeholders were also conducted in like fashion. Tackling issues and finding solutions became more arduous and time consuming with the implementation of work from home policy in the Klang Valley.

However challenging, as the saying goes, 'the show must go' and the challenges and issues that members faced during the lockdown and thereafter were dealt with, as far as possible, by BC in the best interest of its members. For the information of our members, some of the salient issues that cropped up and dealt with or still being dealt with are, as follows:

1. THE LEXIS NEXIS SUIT

In a nut shell, the Lexis Nexis (LN) suit arose from the noble intention of BC to provide legal research tools at an extremely reduced price to all Bar members but unfortunately it ended up in a legal suit filed by LN against the Malaysian Bar that is still pending in court (LN suit). A special ad hoc committee headed by the Vice -President, Mr. Surindar Singh and comprising some Councillors and the legal team handling the suit was convened to look into ways to bring this legal saga to an end. After numerous meetings and much deliberation by the ad hoc committee throughout most part of the year (and still ongoing) an attempt at settlement was reached in principle with the help of the mediating judge, subject to the approval by 2/3 of the members present and voting in an EGM. Bearing in mind, the issue of possibly running afoul of competition law, if the other legal research tool providers were excluded in the exercise, another ad hoc committee was set up to look into inviting tenders from others similar service providers like LN. Tenders were received from CLJ, Digital Library (E- Law), Thompson Reuters and Percetakan Negara Malaysia Berhad so that all legal research tool providers' packages can be put before the member simultaneously for consideration. Upon completion of this massive exercise by the Council, it culminated in 5 motions being put up in an EGM held on 25.9.2021 in the hope that members would consider accepting all or any of the legal research tool packages but unfortunately none of the motions were carried. The consequence of the said failures, is that, as far as the LN suit was concerned, it could not be resolved amicably and is still pending in court. The LN suit is now fixed for trial on 1.7.2022, 21.11.2022, 25.11.2022 and 4th to 6th January, 2023. Notwithstanding the hearing dates being fixed, the suit is still fixed for case management on 9.5.2022 and BC has still not given up hope and still endeavouring in the hope that the said saga can be resolved in a manner which will produce a win - win outcome for all concern.

2. MALAYSIAN BAR PROFESSIONAL INDEMNITY SCHEME (MBPIF)

At the Malaysian Bar 2009 AGM, the general body approved a proposal to set up a Self-Insurance Fund (SIF) which as now been renamed as MBPIF. At the moment our members are insured under a Mandatory Insurance Scheme with a local insurer and are substantially re-insured with an International Re-Insurer and the annual gross premium exceeds RM20 million. The draft MBPIF rules prepared by the relevant committee has been approved by the AGC and the same were circulated to members vide Circular 445/2021 to obtain feedback. The Bar Council appointed Marsh Insurance Brokers (M) Sdn. Bhd. as the Manager for the MBPIF Scheme 2022 for the tenure of 2+1. However as there remains concerns as regards the legality of the said Scheme the matter is still needs deliberation before moving forward.

3. ASSISTANCE TO MEMBERS AND INNOVATIONS BROUGHT ON BY THE PANDEMIC

When the lockdown was imposed the Council had to grapple with numerous issues faced by its members, particularly in respect of cases pending in court as well as access by member to their legal firms. To compound matters, the need for legal representation in criminal matters did not grind to a halt as law enforcement continued and this is where our members who were lawyers under the YBGK scheme played an important role in ensuring that continuous legal representation was present. At the same time some of members were financially affected by the pandemic and the lockdown and BC had to think out of the box and take pro-active steps to help and sustain those members in practice. With a view to that an Ad Hoc Pandemic Relief Committee was set up to liaise with other relevant already existing committees to see how financial assistance can be channeled to the affected and deserving members and at the same time reducing overheads involved in operating a legal firm as well as subsidizing statutory payments. In terms of actual practice, for instance, the Conveyancing Committee was tasked with looking into ways to overcome obstacles involved in conveyancing practice, particularly as regards execution of documents where the law mandated that certain documents can only be executed in the presence of the solicitor. To alleviate some of the problems BC has inter alia approved or looking into the following matters:

- a) it absorbed the increase in the premium insurance amounting to RM112.90 per member for the current year which based on a membership of 21,000 translates to a subsidy of RM2,370,900.
- b) a waiver of RM120.00 per member for the current year statutory contributions.
- c) rules were approved for the creation of a virtual legal office which reduces tremendously the financial resources needed to open and operate a legal firm in the conventional sense.
- d) expanding and extending the scope of group law practice, which is essentially sharing of a common-chambers to reduce cost.
- e) looking into permitting execution of documents digitally, electronically or remotely in the case of documents where it is legally mandated that it must be executed in the presence of a solicitor but this has not been implemented yet as it requires amendments to the existing laws.

4. LEGAL SUITS

The BC is compelled at times to institute legal suits against certain parties without fear or favour as statutorily provided to uphold the rule of law and the cause of justice and at the same time protect the interest of the legal profession as well as that of the public. In that respect some of the legal suits need mentioning are as follows:

a) MALAYSIAN BAR SUIT AGAINST GOVERNMENT OF MALAYSIA

This suit was commenced to challenge the validity of the emergency imposed by the Government of Malaysia to "manage" the crisis brought on by the Covid 19 pandemic by the Emergency Ordinance. Although the emergency has been revoked by the Government on 2.8.2021 but the Council has taken the position that public interest dictates that the Federal Court decides on the validity of the imposition of the said emergency. The reference to the Federal Court on constitutional law questions is fixed for hearing on 14.3.2022.

b) TAN SRI MUHAMMAD SHAFEE ABDULLAH'S SUIT AGAINST MALAYSIAN BAR

In 2015 Malaysian Bar (MB) AGM, Tommy Thomas (now Tan Sri) and Dato' VC George (now Tan Sri) moved a motion to censure Tan Sri Muhammad Shafee (TSMS) pertaining to his conduct in the general election prior to that. The motion was circulated but not put before the house as TSMS had obtained a stay. Arising from the circulation of the said motion, TSMS commenced a legal suit against the MB and the Federal Court found BC was in breach of its statutory duty towards the TSMS in circulating the motion and has referred the matter to the High Court for assessment of damages. The BC after seeking legal opinions has decided to file a review in the Federal Court as the decision effectively means that BC is now tasked with filtering motions proposed by members before circulating them and this may not sit well with some of the members and an arduous task. The review was filed in the Federal Court on 1.12.2021 and at the same time BC has filed an application to stay the proceedings for assessment of damages on 17.12.2021.

c) UNQUALIFIED MEMBERS OF THE PUBLIC PROVIDING LEGAL SERVICES

To protect the interest of its members the Council has commenced a number of legal suits to shut down entities, either operating openly or otherwise in providing legal services to unsuspecting members of the public. This is an ongoing battle, and in an attempt to stamp it out the Council besides taking continuous legal actions has also decided to write to the Registrar of Business/Company and/or any third parties requesting them to liaise with BC before approving the registration of the entity or dealing with any entity claiming to provide legal services so that it does not run afoul of the law.

5. DATA COMPLIANCE REPORT (DCR) 2021 BY BANK NEGARA MALAYSIA(BNM)

In an effort to fight money laundering and anti – terrorism financing (AMLATFA) the filing of the DCR to BNM was made mandatory for legal firms deemed "reporting institutions" who were carrying out "gazetted activities". The BC was concerned with whether the information required in the DCR as well as the permitted follow up action by BNM under the law against the individual firms would run afoul of the "solicitor-client privilege" aspect of practice and therefore although still in discussion with BNM, BC has not completely dismissed the idea of taking this matter to court to determine

the parameters of such encroachment, if any as was done by BC in the case against the Income Tax Department. Also, on another front the subcommittee on AMLATFA, which is headed by our Chairman Babu Raj is working with BNM to allow BC to self – regulate its members on this issue.

6. RULINGS ON SEXUAL HARASSMENT

This ruling was drafted by the Legal Profession Committee and thereafter looked into by the Women Right's Committee and after much deliberations and discussion by the Councillors, it saw the light of the day in the form of Ruling 14.29 under Chapter 14 entitled "Professional Practice" where now sexual harassment constitutes misconduct under section 94 (3) of the Legal Profession Act 1976.

Although it is not possible to highlight each and every issue debated at Council but rest assured that no stone is left unturned in an attempt to do what is in the best interest of all concern. Being in BC also means the need to head or serve in various committees and in that regard, I was the National Co-Chairman of the YBGK Committee and a Committee Member of the Lexis Nexis Committee, the Ad hoc Pandemic Relief Committee and the Court Liaison Committee.

I take this opportunity to thank the Members of the Perak Bar for giving me the pleasure to serve as your Bar Council Representative and to Perak Bar Chairman as well as the Committee for their support and cooperation. I fervently hope that more members of our Perak Bar will get involved in the numerous committees in Bar Council, numbering more than 50 so that we are kept appraised of the latest development at the highest level.

ALTERNATIVE DISPUTE RESOLUTION / PUBLICATIONS SUB-COMMITTEE

The year had been subdued as the ADR committee in Bar Council also struggled to get the training programmes done. Many a physical training had to be rescheduled and finally the committee came up with a Online Mediation Skills Training Course from the 6th to 12th December 2021. It was the first time the Mediation training had been done online. It was a successful one despite some minor setbacks. The committee hopes to tweak and improve it for the next one in case the physical trainings still cannot be done.

The Mediation Committee and Bar Council has also launched the Mediate First campaign wherein it is a campaign in line with the objective of Pusat Mediasi COVID-19 ("PMC-19") to provide an alternative dispute resolution platform for members of the public, Small and Medium Enterprises ("SMEs") and any parties that are unable to perform certain contractual obligations as a result of the restrictions that have been imposed due to the COVID-19 pandemic — for lawyers, law firms, Government-linked companies ("GLCs"), public-listed companies ("PLCs"), SMEs, business chambers, and associations.

The COVID-19 Mediate First Campaign has the privilege of the Government's support where Mediate First Law Firms will be featured on the PMC-19 website and supporting lawyers may charge fair and reasonable rates as they wish when advising and representing parties in pre-action mediation. No lawyer or law firm is obliged to act or render (pre-action mediation) services for free. A virtual "Mediate First" badge will be given to all law firms who sign the COVID-19 Mediate First Pledge. The "Mediate First" badge will signify the law firm's support for swift problem-solving for COVID-19-related matters and the law firm's participation in a first global mediation initiative of this nature

CONVEYANCING SUB-COMMITTEE REPORT

The year 2021 proved to be even more challenging than the previous for conveyancing lawyers in Perak when dealing with PTG and the various land offices throughout the silver state. With the imposition of further lockdown measures by the powers that be and with the registering authorites at PTG and Land offices, Perak operating at minimal staff capacity, attending to presentations of instruments of dealings and other applications, posed numerous problems and the going was tough for all of us. Be that as it may, this Sub Committee has tried its utmost best to deal with and address complaints/grouses/ criticisms from members of the Bar practising conveyancing, bearing in mind that many factors come into play when approaches are made to tackle problems faced in everyday practice. In respect of this, I place on record my appreciation to those who lent a helping hand in managing the conveyancing portfolio during the year 2021. In particular, my heartfelt thanks to Ms Lee Pooi Mun for her invaluable time and effort in assisting and accompanying me to the numerous formal and informal meetings held throughout the year with the office of the Pengarah, PTG Perak and his able officers. Ms Lee's input and advice on many matters have eased my responsibility as the Chairperson and helped me tremendously in executing duties to the best of my abilities.

Below is a summary of the activites/ meetings/ circulars/ updates on various matters that this Sub Committee was handling throughout the year. Though not exhaustive, the list provides a comprehensive report for members information. From the commencement of the new term by this Sub Committee, request was made via circular dated 3.3.2021 issued to members for feedback/ comments/ queries/ complaint on any matter pertaining to dealings with PTG & LHDN, Perak.

- 1. Dicontinuance of Digital Franking System (DFS) at LHDN- members were requested/ encouranged to utilise the STAMPS for all stamping purposes as DFS was to be discontinued effectively on 30.6.2021.
- 2. On 1.4.2021, a Memorandum was presented by the Chairman of the Perak Bar Committee, myself on behalf of the Conveyancing Sub Committee & the Chairman of the Kelab Kakitangan Firma Guaman Ipoh ("Runners Association") to the office of the Pengarah, PTG Perak, setting out concerns and views by members on the implementation of the e-TANAH system which came into effect on 15.2.2021. A copy of this memorandum was sent out to members via a circular on 21.4.2021.
- 3. On 14.4.2021, I was invited to take part in a online meeting with the secretariat of the Technical Working Group on Registering Properties under PEMUDAH and a representative of JKPTG from Putrajaya to highlight issues pertaining to the implementation of the e-TANAH system.

- 4. For the month of May 2021, members were notified of the limited operational hours at PTG, Ipoh for presenting instruments of dealings and applications for MB/ State Authority consent & only limited number of firms and presentations were allowed on designated days. The closing of operations at PTG & Land offices all over Perak continued well into the month of June 2021.
- 5. Prior to PTG reopening counters for presentation in July 2021, attempts were made to engage with the officials to work out a feasible mechanism for firms to present their documents, but to no avail. At a meeting on 5.7.2021, PTG officers informed us that walk-in presentations would no longer be entertained and members were to utilise the online appointment system on the PTG website. PTG was to directly inform the firms of the appointment date and daily presentations were initially capped at a mere 40 with maximum presentations of 5 per firm. Meanwhile, many firms were anxiously enquiring on exemption of penalty payments for late presentations which was due to end on 31.8.2021. A further issue which arose related to the expiry of the validity period of the MB/ State Authority consent to transfer, which members were unable to comply with due to difficulty in presenting their documents as a result of the daily quota. These were eventually resolved with the relevant authority granting extensions.

Several letters and follow up meetings were held with the Timbalan Pengarah Tanah & Galian (Bhg Hakmilik) and his officers in early July 2021 followed by an official meeting with Dato Pengarah on 26.7.2021 where the issue of backlog in presentations and the difficulties faced by members in not being able to present their documents, were brought up.

- 6. Further meetings were held with PTG officials in August 2021 to attempt to resolve the delay in obtaining appointment dates for presentations. Due to the high volume of online applications on the e-temujanji, the system was temporarily suspended. Effective 9.8.2021, the number of daily presentations were capped at 150. Meanwhile, presentation counters at PTG continue to be operational at minimal capacity due to the continuance of the movement control orders and the rising number of COVID positive cases amongst the staff.
- 7. With the concensus of all stakeholders including the Real Estates Housing Developers Association (REHDA), the Runners Association came up with a temporary solution in creating a weekly appointment schedule in August 2021. Though not entirely satisfactory, their attempt was laudable having regard to the limitations that the Association had to work with. My sincere gratitude to Mr Udaya Shanker and En Syed Khushairi, the Chairman and Deputy Chairman respectively, of the Runners Association for liasing with runners, PTG staff/ officials and various lawyers and legal firms within and outside of Perak in coming up with the appointment schedule, which was no easy task. The weekly listing was put up on the Perak Bar website for members information.
- 8. By early September 2021, there was a need for this Sub Committee to take over the task of preparing the weekly schedules. Together with Ms Lee, many hours, days and weeks were spent preparing a workable system that in our view, catered to all firms having problems with obtaining appointments at PTG. A barrage of criticisms and complaints and thinly veiled threats came our way from lawyers and others who chose to be deliberately oblivious to the fact that our only

aim was to offer some assistance to those who have been waiting for months to present their documents. A thankless experience indeed which was compensated in some way by the acknowledgement of gratitude we received from other lawyers who genuinely understood and appreciated our efforts.

- 9. Special arrangements were made with PTG for legal firms having high volume of documents, to be present on designated Saturdays.
- 10. By mid October 2021, we were ready to hand over the appointment system back to PTG and informed them of the same. All schedules up to 31.10.2021 were drawn up and completed by us. Effective November 2021, PTG resumed the responsibility of fixing the appointments.
- 11. Follow up meetings with PTG culminated with the announcement of a Special Task Force by PTG effective 10.11.2021 to address the issue of runners/ lawyers/ members of the public having to gather in the wee hours of the morning and in some instances even the night before, just to be the first few in line to have their names in the list for limited presentations for the next working day. The establishment of this task force was long overdue and proved to be very effective in clearing the huge volume of daily presentations numbering in excess of 700 on some days! Thereafter, the going was smooth until the end of the year as members were able to present their documents without limitation and without the need for prior appointment.
- 12. This year also witnessed Perak Bar engaging with LPPSA (Mortgage Dept) on 30.9.2021 via Googlemeet which was successfully attended to by our members.

Most notably, we had Justice Su Tiang Joo to share some thoughts on Ex-parte Application which was done with the collaboration of the Judicial Officers of the Ipoh High Court which in-turn was a insightful and knowledgeable talk.

Furthermore, the Perak Bar Committee has been committed in solving issues faced by its Members by ensuring every bit is conveyed to the relevant Court officers who have handled the matters in the best possible manner, keeping in mind of the lawyers and the public's safety, and at the same time having tried their level best into dealing/proceeding with our matters.

In a nutshell, the Judiciary, nationally and locally had done a brilliant job in handling and managing its matters amid the Covid-19 pandemic.

With the ushering of the new year, 2022, we may note that things will not go back as it were pre-Covid, however, we as Lawyers must learn to adapt to the new norm for the greater good.

1. <u>Meeting and Discussion Between SLC, PGSM Perak and Members on the model Akta Profession Guaman Syarie (Wilayah-Wilayah Persekutuan) 2019 (APGS 2019)</u>

The Committee organised and held a hybrid meeting with the stakeholders above mentioned to obtain input from all related to the possible adoption or adaptation of the APGS 2019.

2. SLC meeting with Perak State Legal Advisor (SLA)

The Committee had a meeting with YB Dato' Azmir Shah Bin Zainal Abidin, Perak SLA on 30.09.2021 where the issue of APGS 2019 was brought to the SLA's attention as a model for Perak together with other issues on Waqaf and Hibah laws.

3. <u>SLC meeting with Syariah Chief Judge, Y.A.A Tuan Hj Ab. Rahman Thobroni B Mohd Mansor and the Syariah Court</u>

A meeting was held on 25.10.2021 with YAA Ketua Hakim Syarie, Perak on matters concerning the Administration of Syariah Laws and Practice in Perak. The issue of APGS 2019 was highlighted to YAA Ketua Hakim Syarie.

Among the issues brought up includes;

- i) Concerning Enakmen Mahkamah Syariah Perak
 - YAA informed that Syariah Court had introduced one committee known as Jawatankuasa Kehakiman Syariah, with 7 corum.
- ii) Introduction of the concept of "Kekeluargaan Kehakiman" by YAA, where the members are encouraged to help each other when and where needed.
- iii) YAA also expressed his high hopes that Enakmen Mahkamah Syariah (Perak) become a model for other states in implementing the said enactment.
- iv) Concerning the issue of APGS 2019, YAA informed that this issue had been brought and discussed among the Ahli Majlis. A Committee will be established to look into and analyse the said APGS 2019 whether it is suitable to be implemented in Perak.

4. SLC Flood Assistance to Victims

Following the heavy rainfall since mid-December 2021 which causes major floods and landslides in several states including Selangor, Pahang, Malacca, Johor, Kelantan and Terengganu, the Committee together with Dato' Hjh Shamsuriah Binti Sulaiman in collaboration with Mr. Muhammad Shuhur Bin Azizuddin had successfully raised funds for the flood victims. The fund was used to buy basis necessities, food and personal hygiene items such as dry foods, eggs, pampers and sanitary pads. Besides, tools and appliances to manage post-flood clean-up was also bought which includes two (2) sets of waterjets, detergents, brooms and brushes. The items were bought according to the specific requests and needs of the victims.

Mr. Muhammad Shuhur has, with his own transport went on three trips to Ulu Langat and Kg Kenangan, Puchong to distribute the material of donation to the flood victims.

5. <u>Collaboration Between PGSM Perak & SLC in Assisting the Flood Victims in Bentong, Pahang</u>

A group of Advocate and Solicitor together with Peguam Syarie were involved in this flood relief mission in Bentong, Pahang on 08.01.2022. A convoy of 3 four-wheel drive vehicles (4X4) departed from Perak to Bentong, Pahang to distribute the donations which was brought according to the specific requests, needs or demands of the victims in order to avoid any surplus in the donation. The convoy went from house to houses to distribute the donations to the flood victims with high hopes that this donation can lessen their burden.

6. Colloquium Held by Syariah Court in Collaboration with PGSM as well as Civil Court

Three speakers were invited to present their talks and share their input with the participants. The speakers were;




Fig 1:- Significant increase in active user during MCO3.0.




Fig 2: Zoom Meeting with Judicial Officers of Perak Courts with Perak Bar Committee.
