OVERVIEW

Azmi Mohd Ali is the senior partner of Azmi & Associates, a full service corporate and commercial law firm with offices in Kuala Lumpur, Johor Bahru and Penang. He holds an LL.B (Hons.) from the University of Malaya (1984) and an LLM in US & Global Business Law from Suffolk University, Boston, U.S.A (2011). He also attended a short programme on Enterprise Innovation at Cambridge University Business School.

He focuses on corporate laws with experience in the areas of mergers and acquisitions, joint ventures, cross-border transactions, project finance, privatisation, energy, oil and gas, and foreign investments.

Prior to his venture in private practice, he spent 6 ½ years as an inhouse counsel at Petronas. He was involved in projects of national importance for Malaysia and negotiated and concluded the NGPSA, a major gas development project for Malaysia, in 1990. He left Petronas to pursue a career in law practice in 1990 and has been in practice since then.

He was awarded in the Legal 500 Hall of Fame for M&A / Corporate 2020, "Distinguished M&A Practitioner" for AsiaLaw 2020, "International Law Office 2016 Clients Choice Award for Malaysia in Mergers & Acquisitions", and other international publications.

Currently, he is a director of 3 listed companies, an unlisted real estate investment company, and he also sits on the Investment Committee Panel of Lembaga Tabung Angkatan Tentera, and the Appeals Committee of Bursa Malaysia.

He had previously served as a director at Sime Darby Berhad, 5 other listed companies, and an Islamic bank. He is one of the 16 elected Bar Council councillors elected from the floor for two terms from 2023 to 2025.

He has been involved in strategic management of a number of litigation cases, as well as arbitration cases (with others) under the UNCITRAL Arbitration Rules and the LCIA Rules. He has also acted as an arbitrator in one arbitration case under the AIAC Arbitration Rules.

He is a member of the International Chamber of Commerce Malaysia ("ICC Malaysia"), member of the Panel of Conciliators and Panel of Arbitrators, and International Centre for Settlement of Investment Disputes ("ICSID").



Cindy Goh Joo Seong is the head of the intellectual property ("IP") department and a litigation partner in Cheang & Ariff with more than 20 years of experience.

Her areas of focus include IP, corporate litigation, commercial disputes, tax litigation, etc. Cindy is also the current Chairperson of the Bar Council IP Committee, a council member of APAA Malaysia and a committee member in numerous IP associations. She was also named as "Asia-Pacific Female Lawyer of the Year" by Benchmark Litigation Asia-Pacific Awards 2022.



S Saravana Kumar is the head of the tax, sales and service tax ("SST") and customs and Partner at Rosli Dahlan Saravana Partnership. - No additional registration will be accepted once the closing date has passed, or if the CPD event is full.


- The CPD Department may not permit future registration if you fail to attend a CPD event after registering unless you provide an acceptable and valid reason(s).
